

## COBB TUNING PRODUCTS LLC ACCESSTUNER PRO TERMS AND CONDITIONS

**PLEASE READ THIS SOFTWARE LICENSE AGREEMENT CAREFULLY. BY DOWNLOADING, INSTALLING OR USING THE SOFTWARE YOU INDICATE ACCEPTANCE OF AND AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, DO NOT DOWNLOAD, INSTALL OR USE THE SOFTWARE.**

This agreement (the "Agreement") is made between COBB Tuning Products, LLC ("COBB") and you, the customer ("Licensee"). The terms and conditions of this Agreement are intended by the parties as a final expression of their agreement with respect to the subject matter hereof and may not be contradicted by evidence of any prior or contemporaneous agreement. This Agreement shall constitute the complete and exclusive statement of the terms and conditions and no extrinsic evidence whatsoever may be introduced in any judicial proceeding, which may involve the Agreement. This Agreement supersedes any other written agreements between you and COBB and may not be modified except by a writing executed by both parties hereto.

### SECTION 1. GENERAL PROVISIONS

The provisions of this Section 1 shall apply to any and all Software, as defined below.

**1.1 Software.** For the purpose of this Agreement, the Software Subscription License/HASP Key will be referred to as the "License" and the licensed Accesstuner Pro computer software program(s) downloaded and/or installed, and the supporting documentation for such, will be referred to as the "Software".

**1.2 Restrictions.** COBB reserves any rights not expressly granted to Licensee and retains title and full ownership rights under the copyright laws of the United States or any other jurisdiction or under any federal, state, or foreign laws. COBB is not obligated to provide and Licensee acquires no right of any kind with respect to any source code for the Software. Licensee agrees that it has no right whatsoever to modify the Software or any portion thereof in any manner. Licensee shall not, nor permit any third party to reverse engineer, decompile, disassemble or otherwise reduce the Software to any other humanly perceivable form, and may not modify, adapt, rent, lease, loan or create derivative works based upon the Software or any part thereof.

**1.3 Licensee qualifications.** Any active License is dependent upon the current and satisfactory status of Licensee as a COBB Authorized Dealer. Dealer status provisions are outlined in the COBB Authorized Dealer Agreement, COBB Terms and Conditions Policy, and COBB Minimum Advertised Price Policy, all available upon request.

**1.4 Export Law Assurances.** Licensee shall not export or re-export, or allow the export or re-export of the Software or any copy, portion or direct product of the foregoing, in violation of any export laws, restrictions, national security controls or regulations of the United States or other applicable foreign agency or authority.

**1.5 Limitation of Remedies and Damages.** IN NO EVENT WILL COBB, ITS SUBSIDIARIES, OR ANY OF THE LICENSORS, DIRECTORS, OFFICERS, EMPLOYEES OR AFFILIATES OF ANY OF THE FOREGOING BE LIABLE TO LICENSEE UNDER ANY CONTRACT, NEGLIGENCE, STRICT LIABILITY OR OTHER LEGAL OR EQUITABLE THEORY FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT OR SPECIAL DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION AND THE LIKE), WHETHER FORESEEABLE OR UNFORESEEABLE, OR FOR COST OF PROCUREMENT OF SUBSTITUTE GOODS, TECHNOLOGY OR SERVICES, REGARDLESS OF THE BASIS OF THE CLAIM AND EVEN IF COBB OR A COBB REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. COBB'S CUMULATIVE LIABILITY FOR DAMAGES FOR ANY CAUSE WHATSOEVER, AND REGARDLESS OF THE FORM OF THE ACTION, WILL BE LIMITED TO NO GREATER THAN THE CURRENT MONTHLY SOFTWARE SUBSCRIPTION AMOUNT PAID TO COBB FOR THE SOFTWARE THAT CAUSED THE DAMAGES. NO ACTION MAY BE BROUGHT AGAINST COBB LATER THAN ONE YEAR FROM THE TERMINATION OF THIS AGREEMENT.

**1.6 Nondisclosure.** "Confidential Information" shall be defined to include the Software, source code, object code, screen shot, screen capture, documentation and any proprietary tools, proprietary knowledge or proprietary methodologies disclosed by COBB to Licensee under or relating to this Agreement. Licensee shall observe complete confidentiality with respect to the Confidential Information, and shall use its best efforts and take all reasonable steps to protect the Confidential Information from any use, reproduction, publication, disclosure, or distribution except as specifically authorized by this Agreement. Licensee shall promptly notify COBB of any known unauthorized use or disclosure of the Confidential Information and will cooperate with COBB in any litigation brought by COBB against third parties to protect its proprietary rights.

**1.7 Assignment.** Licensee may not assign or transfer its rights and obligations under this Agreement without prior written approval by COBB and any purported assignment or transfer without COBB's consent shall be null and void.

**1.8 Injunctive Relief.** Licensee hereby expressly agrees that COBB, in addition to any other rights or remedies which COBB may possess, shall be entitled to injunctive and other equitable relief without having to post bond or other security to prevent a material breach or continuing material breach of this Agreement.

**1.9 Software Supplied to the Government.** The Software is a "commercial item," "commercial computer software" and/or "commercial computer software documentation." Consistent with DFAR section 227.7202 and FAR section 12.212, any use, modification, reproduction, release, performance, display, disclosure or distribution of the Software by the U.S. government shall be governed solely by the terms of this Agreement and shall be prohibited except to the extent expressly permitted herein.

**1.10 Survival.** Sections 1.2, 1.3, 1.4, 1.5, 1.6, 1.7, 1.9, 1.10, 1.11, 1.12, 1.13, and 1.14 shall survive termination of this Agreement for any reason whatsoever.

**1.11 Warranties.** COBB warrants that it has the legal right to grant Licensee the License as defined by this Agreement. COBB also warrants for a period of thirty (30) days from the delivery date of the Software

that (i) the media provided by COBB, if any, on which the Software is recorded will be free from material defects in materials and workmanship under normal use, and (ii) the operation of the Software, as provided by COBB, will substantially conform to COBB's published documentation for the Software. In the event Licensee notifies COBB during the warranty period that the Software does not meet these standards, COBB shall, at its sole option and expense, either replace the media, refund the subscription price, or repair or replace the Software as Licensee's sole and exclusive remedy.

THIS LIMITED WARRANTY IS THE ONLY WARRANTY PROVIDED BY COBB WITH RESPECT TO THE SOFTWARE LICENSED UNDER THIS SECTION, AND COBB EXPRESSLY DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

**1.12 Term and Termination.** The License is effective for the duration of one month ("Subscription Term") and will extend to the next Subscription Term for the term of the Agreement grant unless sooner terminated, either through mutual agreement by the parties, non-payment of Subscription fees, or by Licensee's material breach of the Agreement; provided, however, Licensee shall have ten (10) days from written notice to cure any such breach if curable. Upon any termination Licensee must immediately destroy the Software and all accompanying written materials and all copies thereof (including copies stored in computer memory) and shall so certify to COBB in writing.

**1.13 Data Collection.** Licensee hereby expressly agrees that COBB may collect and use information ("Data") about Licensee's computer hardware, operating system, and Software. The Data collected includes parameters uniquely identifying the computer hardware, crash and usage details, and related information. This Data is gathered for securing intellectual property, troubleshooting, analyzing the health of service, and improving the Software and services; the Data is also aggregated and analyzed anonymously for marketing purposes. COBB will not disclose any Data to any third party.

**1.14 General.** This Agreement will be construed under the laws of the State of Texas, except for that body of law dealing with conflicts of law and the U.N. Convention of Contracts for the Sale of International Goods, which shall not apply. In the event there is a dispute concerning the subject matter of this Agreement, the proper venue shall be the County of Travis, State of Texas, United States of America. Each party hereby waives opposition to jurisdiction in such court. Service of process can be done in accordance with the governing law of the Agreement. Performance of any obligation required by a party hereunder may be waived only by a written waiver signed by the other party, which waiver shall be effective only with respect to the specific obligation described therein. If any provision of this Agreement shall be held by a court of competent jurisdiction to be contrary to law, that provision will be enforced to the maximum extent permissible, and the remaining provisions of this Agreement will remain in full force and effect.

## **SECTION 2. LICENSE, RESERVATION OF RIGHTS, DELIVERY**

**2.1 License Grants** Subject to the terms and conditions of this Agreement, including the payment of all applicable fees, COBB hereby grants to Licensee, solely for internal business operations, a limited, non-exclusive, non-transferable right and license to: (a) Use the Software during the Subscription Term, subject to the applicable License Type restrictions; (b) Permit Affiliates or third party contractors

performing services on Licensee's behalf to use the Software in accordance with the terms and conditions of this Agreement provided that (i) such use must be solely for the benefit of (ii) Licensee shall be responsible for all acts and omissions of such third parties and; (c) Software are installed on no more than one computer per active License except by a written agreement executed by both parties hereto.

Licensee further understands and agrees that:(i) upon receipt by COBB of payment in full for the then-current Subscription Term, Licensee will be provided with a License that is effective for the duration of such Subscription Term;(ii) in case of breach by Licensee of the payment terms stipulated in this Agreement, COBB will have the right to suspend the License and such suspension will not give rise to any modification of the amount of the Subscription fees or to any extension of the Subscription Term;(iii) the Software will, in the absence of any renewal of the Subscription Term, be disabled automatically upon the expiration of the Subscription Term and (iv) the License will automatically prevent the use of the Software in violation of the applicable License Type restrictions, as set forth in the Order Form.

You may not use the Software if you do not have an active License.

**2.2 Reservation of Rights; Restrictions.** COBB owns all right, title, and interest in and to the Software and any derivative works thereof. COBB retains all intellectual property rights in the Software, and any accompanying written materials provided by COBB including, but not limited to, copyright. No other license to the Software is granted to Licensee by implication, estoppel or otherwise. Licensee understands and agrees that Licensee's ability to use the Software is determined by the License provided to Licensee. Licensee agrees not to: (i) prepare derivative works from, modify, copy or use the Software in any manner; (ii) attempt to circumvent, disable or defeat the limitations on Licensee's use of the Software governed under the License; (iii) transfer, sell, rent, lease, distribute, sublicense, loan or otherwise transfer the Software or the generated code in whole or in part to any third party; (iv) alter or remove any part of Software.

**2.3 Delivery.** The Software is only available electronically via download and will not be available in any other format. The Software shall be deemed delivered to Licensee upon COBB making available to Licensee the License. Licensee understands and agrees that a License provided by COBB is required to enable the Software and that License is valid only during the Subscription Term.

## **SECTION 3. FEES, PAYMENT**

**3.1 Fees.** Licensee agrees to pay COBB the applicable Subscription fees stated in the COBB Accesstuner Pro Subscription Fee Schedule, available upon request. Unless otherwise specified, Subscription fees for the Subscription Term shall begin one month after delivery of the Software and shall continue for the term of the Agreement grant unless sooner terminated.

**3.2 Payment.** Continuing through the Subscription Term, each licensee will be charged the applicable Subscription fees per the Fee Schedule. By accepting this Agreement you authorize COBB to automatically renew the Subscription Term and charge the payment method currently on file.
